- INSTALLATION INSTRUCTIONS -

Remove stock sponson blades (5 Torx bolts each side).
DO NOT REMOVE BACKING PLATES.



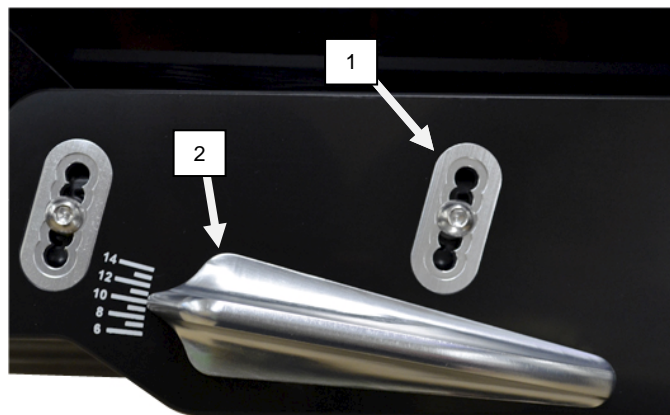
Discard stock sponson blades and hardware.

Clean threaded inserts in stock backing plates using compressed air.

Install supplied Pro-Series Sponsons using supplied M8 bolts & wave washers. **NOTE: Apply blue Loctite to threads. Torque bolts to 13 ft•lb / 159 in•lb / 18 N•m.**

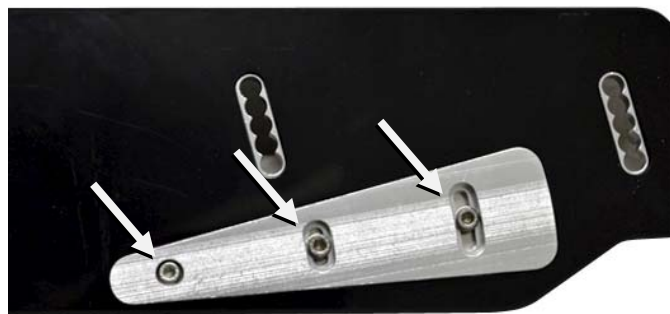


SPONSON TUNING RECOMMENDATIONS



1) Sponson Blades: Billet inserts provide 5 vertical adjustment positions. All the way up is the least aggressive. All the way down is the most aggressive.

2) Stabilizer Wings: The billet stabilizer wings provide 5 degrees of adjustment. They come preset in the neutral position (same as stock). All the way up is the most aggressive. All the way down is the least aggressive. To adjust loosen the three M5 allen bolts on the rear of the sponson blade.



After finding your favorite position remove bolts one at a time, apply blue Loctite to threads and replace. **Torque bolts to 3.5 ft•lb / 44 in•lb / 5 N•m.**

Check bilge for tools, rags, etc. Run craft on a flush kit to check for proper operation.
